BHS Revised Conditions for Returned Spare Parts

Dear customer,

Recently the amount of delayed return deliveries of spare parts has increased noticeably. These delayed return transfers are causing us, as producer and supplier, considerable cost and time efforts.

In order to avoid the transfer of costs it has become necessary to review our previous good will arrangement for returned parts excepting warranty claims. The following conditions are valid from 1st January 2021 and can be changed at any point by BHS Corrugated Maschinen- und Anlagenbau GmbH.

- a) Should new parts be returned within 4 weeks from the date of the delivery note, 100 % of the net value is credited (excluding VAT and shipping cost - in the following called "net value").
- b) If the return takes place 5 12 weeks from the date of the delivery note, 75 % of the net value will be credited.
- c) If the return takes place later than 12 weeks from the date of the delivery note, no credit note will be issued.
- d) The date of goods received at BHS Corrugated Maschinen- und Anlagenbau GmbH, D-Weiherhammer, determines the rate of the credit note.
- e) We reserve the right not to accept returned parts on an individual basis.

- 3. The parts have to be in their original packaging and must be unused and undamaged.
- 4. A fully completed BHS-re-consignment form stating reasons for the return has to be added to the goods (see enclosure "Re-consignment Form").
